Law Number 20 of 2003 concerning the National Education System as the operational basis and message related to civic education. Article 3 paragraph (2) concerning the functions and objectives of the state states that: National education functions to develop and shape the character and civilization of a dignified nation in order to enlighten the life of the nation, aiming to develop the potential of students to become human beings who believe in and are devoted to God Almighty, have noble morals, are healthy, knowledgeable, capable, creative, independent, who become democratic and responsible citizens.

#### Civic Education for National Character Building

According to Rosyada *et al.* 2000, Civic Education can be equated with Democracy Education which aims to prepare individuals as citizens who have the ability to think critically and act democratically. Through various activities, the goal of this education is to instill awareness of the importance of democracy as a form of social life that provides protection for the rights of citizens. In the context of national development and character building, civic education has a very important function and role. Civic education is one type of character education that is

developed systematically and systematically and cannot be separated from the framework of national development, national development, and character policy (Akbal 2016). Education has a strategic role in forming a value system inherent in individuals, which is related to the development of movement and self-esteem as humans in accordance with the order of life in the society that surrounds them.
