This does not mean that understanding values eliminates the legitimacy of standards. Differences in understanding norms greatly create diversity in open recognition from society, not indicating a lack of norms in legal provisions. (Cristianto, 2016). Citizenship Education

Civic Education (PKn) is one of the subjects or fields of study listed in the school curriculum. Several experts have expressed their opinions regarding the 2013 curriculum which has a competency-based concept that emphasizes the aspect of character development. Character education in the 2013 Curriculum aims to develop the quality of the process and results of education that refer to the formation of attitudes and morals of students optimally and are also in line with the graduate competency standards in each educational unit (Mulyasa, 2006).

Discovery Based Learning

Discovery learning method is method interactive and hands-on learning, which was introduced by Jerome Bruner in the 1960s. Bruner emphasized that the learning process should done while practice or learning by doing. With approach this, participants educate involved in a way active, no only just absorb knowledge in a way passive. Discovery Learning illustrates a approach teaching general which reflects development study constructivist for environment education based on school. Bruner (1961) argued that, the practice of self-discovery teaches a person to acquire information in a way that makes the information more readily usable in problem solving. Kemendikbud (2013) and Sinambela (2017) have set six stages in Discovery learning that must be implemented systematically. The six steps are; (1) Stimulation or providing stimulation; (2) Problem statement or problem identification; (3) Data collection or collecting data and information; (4) Data processing or data processing; (5) Verification or analysis and data interpretation or also called proof; (6) Generalization or drawing conclusions. Effendi (2012) and Anitah (2009) explain that Discovery Learning is a form of learning that involves students in solving problems to develop knowledge and skills. Ahmadi and Prasetya (2013) outline the discovery learning procedure. The steps or syntax in the discovery learning model are as follows:

- a. Simulation (Stimulation or Giving Stimulation)
- b. Problem Statement (Problem Statement or Identification)
- c. Data Collection (Data Collection)
- d. Data Processing
- e. Verification (Proof)
- f. Generalization (Conclusion Drawing)

Advantages and disadvantages of various learning models of course, they have different advantages and disadvantages, the advantages of discovery learning are:

- a. Helping students to improve and enhance their cognitive skills and processes
- b. The knowledge gained through this method is very personal and powerful because it strengthens understanding, memory and transfer
- c. Creates a sense of pleasure in students, because of the growing sense of investigation and success.
- d. This method allows students to develop quickly and at their own pace.
- e. Causing students to direct their own learning activities by involving their own reason and motivation.
- f. This method can help students strengthen their self-concept, because they gain confidence in working together with others
- g. Centered on students and teachers, both play an active role in expressing ideas. Even teachers can also act as students, and as researchers in discussion situations
- h. Helping students eliminate skepticism (doubt) because it leads to final, certain or definite truth
- i. Students will understand basic concepts and ideas better
- j. Helping and developing memory and transfer to new learning process situations

The weaknesses of the discovery learning model are as follows:

- a. This model raises the assumption that there is a readiness of mind to learn for students who have academic obstacles will experience abstract or thinking difficulties, expressing the relationship between written or oral concepts, which in turn will cause frustration
- b. This model is not efficient for teaching a large number of students, because it takes a long time to help them find theories or other problem solving
- c. The expectations contained in this model will be confused if faced with students and teachers who are used to old ways of learning
- d. More suitable for developing understanding, while developing aspects of concepts, skills and emotions as a whole receives less attention

Conclusion

Introduction of normative behavior at elementary school level involves Discovery-Based Learning (DBL) approach which has proven successful in forming honest and responsible students' character. Civic Education which is based on Discovery-Based Learning (DBL) enable students to understand and make norms as behavior that must be applied in life daily.
