In Law number 14 of 2005 concerning teachers and lecturers in article 20 concerning teachers' duties (Rohman and Lamsuri, 2009), namely: (1) Planning learning, implementing a quality learning process, and assessing and evaluating learning outcomes (2) Continuously improve and develop academic and competent qualifications in line with developments in science, technology and art (3) Acting objectively and not discriminatorily based on considerations of gender, religion, ethnicity, race, and certain physical conditions, or family background, and socio-economic status of students in learning (4) Uphold statutory regulations, laws and teachers' codes of ethics, as well as religious and ethical values (5) Maintain and foster national unity and integrity. In law number 14 of 2015 there are regulations that explain the code of ethics for teachers, professional teachers and religious values that every teacher must have, because they are one of the main requirements for realizing quality education. Good teacher professional ethics can explain and carry out the learning process well and implement it with a good attitude (Islammilyardi and Sopiansah, 2019). The code of ethics for teachers in Law number 14 of 2005 concerning teachers and lecturers article 41 is: (1) Teachers can help independent professional organizations (2) Professional organizations as referred to in paragraph function to advance the profession, improve professional competence, career, educational insight, professional protection, welfare and service to the community (3) Teachers are required to be members of professional organizations (4) The formation of professional organizations as intended in paragraph 1 is carried out in accordance with statutory regulations (5) The government and/or regional government can facilitate professional teacher organizations in carrying out guidance and developing the teaching profession.

The continuation of article 42 of law number 14 explains that professional teacher organizations have the authority, namely: (a) Establishing and enforcing a code of ethics for teachers. (b) Providing legal assistance to teachers. (c) Providing protection for the teaching profession. (d) Continuing coaching and professional development of teachers. (e) Advancing national education. So the application of the code of ethics and authority of professional teacher organizations aims to increase teacher insight and serve as a guide for teachers in carrying out their profession as teachers. The learning process is an activity carried out by a teacher who explains learning to students. Effective learning is a learning activity that makes students learn simply, feels happy and makes it easier for students to receive the desired results (Junaedi, 2019). Teachers must provide feedback and help students with boredom and obstacles. Good feedback will generate student interest and produce a comfortable and enjoyable atmosphere in the classroom (Junaedi, 2019). In the learning process, teachers cannot expect all students to be able to accept the material being taught due to differences in understanding of learning. Teacher thinking like this is the thinking of teachers who are less than professional in carrying out their duties as a teacher, the pessimistic nature of teachers can have an impact on students, where teachers should be someone to imitate for students. Because the teacher's success in teaching ethics and professionalism greatly influences the classroom.
