This means that a job or position called a profession cannot be held by just anyone, but requires special preparation and training (Heri Susanto, 2020: 11). Professional ethics is one of the moral standards to be called a professional, namely being able to make decisions on a problem, being full of responsibility and having skills and abilities. It can be said to be effective if it is based on the values and ideals that exist in the environment and is the application of individual moral standards. Professional ethics is also a benchmark in efforts to prevent unethical behavior carried out by members of the profession. In professional ethics it is known as a code of ethics. A professional code of ethics is rules that are written firmly and clearly about the norms that individuals in a profession need to pay attention to in order to carry out their duties in accordance with their profession and in public life. The code of ethics in a profession is: (a) Promote a positive image of the profession (b) Develop and improve the quality of service of professional members (c) Develop and improve the quality of the profession (d) Improving the welfare of members of the profession (e) Have a strong network of professional organizations (f) Prioritize service over personal interests (g) Developing and improving organizational quality in a profession.

Result & Discussion

Teacher Professional Ethics

Ethics is a word derived from the Greek word "ethos" or in plural form it can be called "ta etha" which means habit. Ethics is often confused with morals because "moral" or "morality" is a word taken from the Latin "mos" or "mores" in its plural form which both have the meaning of habit. The meaning of ethics is not only limited to the attitudes and behavior that occur but also includes the motives or reasons behind someone doing that thing. Meanwhile, the meaning of morals is limited only to visible attitudes and behavior. In Indonesia, ethics is often referred to as "susila" or "decency". This word is taken from Sanskrit which means good attitudes or actions that are in accordance with the norms and rules of social life. Ethics is also part of morals in the Islamic religion which is related to faith, worship and sharia so that in this case lies the difference between Ethics and morals are a broader scope of discussion. Furthermore, the word profession has many meanings, ethics in a profession are used as guidelines for attitudes, behavior and actions both in carrying out tasks and in everyday life. According to the analysis of et al. (2021) there is a purpose in formulating ethics in the teacher code of ethics, namely to help professionals make decisions in dealing with work problems, maintaining professional reputation is the goal of ethical standards, monitoring the behavior, integrity and vocation of professional staff, becoming a moral image of society so that every member professions can consider the code of ethics law in carrying out their professional duties.

(5) As an educator, you must have authority (have advantages in realizing spiritual, emotional, social moral and intellectual values), be independent (able to make your own decisions) (6) As a teacher (providing ease of learning).

Professional ethics are very necessary in the world of education, so in this case education is a forum that can help in instilling the character values of prospective elementary school teachers. Through this implementation, educators are required to be examples and references for students. As educators and advisors at school you must understand mental health and psychology and as a model and example you must behave, speak well and correctly.
