Meanwhile, things that influence this interaction are religion, socio-culture, economics and education.

This research aims to describe: Knowing the condition of diversity in Seputih Raman District. Knowing strategies for maintaining diversity in a multicultural society in Seputih Raman District. Knowing the model of multiculturalism in society in Seputih Raman District.

#### **Research Methodology**

The research used by this researcher is qualitative with a phenomenological approach which is expected to be able to produce in-depth descriptions of speech, writing, and/or behavior that can be observed from a particular individual, group, society, and/or organization in a particular context setting which is studied from the perspective of complete and comprehensive. This research uses a phenomenological approach. Phenomenological research is qualitative research which is intended to examine a particular phenomenon (symptom) experienced by a particular person or a particular group of people (Suwarsono. 2016). The research subjects were the people of Tanjung Rejo Village, who were asked for their opinions regarding the life of the multicultural community of Tanjung Rejo village in maintaining diversity in the digital era. Researchers obtained information from the Village Head and Village officials, hamlet heads, community leaders, and the Tanjung Rejo village community. This research aims to obtain a clearer, more complete picture and information, making it possible and easier for researchers to conduct observational research. Therefore, the author determines that the research location is the place where the research will be carried out. In this case, the research location is located in Tanjung Rejo Village, Percut Sei Tuan District, Deli Serdang Regency, which contains several hamlets. The research was carried out from March until completion. The focus of this research is on the living conditions of the multicultural community of Tanjung Rejo village in maintaining diversity in the digital era. The focus of this research also functions as a guide in discussing the results that have been implemented. This research focus is very important because without a research focus, researchers will be confused and trapped in fulfilling the criteria for the data obtained. #### 3. Documentation

Research subjects are determined using *purposive sampling*, namely a technique for sampling data sources with certain considerations. These particular considerations are, for example, the person who is considered to know best about what we expect or perhaps he or she is the authority so that it will make it easier for the researcher to explore the object/social situation being studied. (Sugiyono. 2017). In collecting data, the technique used was an indepth interview technique with predetermined sources. In this research, the interview topics used were selected in depth so that the data taken could be accurate and relevant. And the data obtained can also be drawn to the same and correct conclusions. The data analysis used is a descriptive analytical method, namely describing the data collected in the form of words, images and not numbers. Data comes from manuscripts, interviews, field notes, documents, and so on, then described so that it can provide clarity on the facts or realities. Miles and Huberman's version of data analysis (in Sugiyono. 2017) states that there are three activity streams, namely data reduction, data presentation, and conclusion drawing.

# 1. Data reduction

Data reduction is carried out by selecting data that is considered basic, which is new and has never been known. Reducing data means summarizing, focusing on important things, looking for themes and patterns, unique data that is different from other data and is data that is relevant to the researcher's question. (Sugiyono. 2017)

## 2. Data Presentation

Data presentation can be done in the form of tables, graphs, charts, and similar. By presenting data, it will be easier to understand what is happening. Plan further work based on what has been understood. (Sugiyono. 2017).

#### 3. Conclusion

Conclusions are drawn by looking at the reduction results and referring to the problem formulation and objectives to be achieved. In the research, conclusions will be drawn from the results of observations, interviews, and reinforced with documentation. Checking the validity of the data produced can be scientifically accountable and trustworthy, so the researcher checks the validity of the data. Checking the validity of the data is a step to reduce errors in the process of obtaining research data which of course has an impact on the end of the research carried out.

To determine the validity of the data, inspection techniques are needed. The implementation of inspection techniques is based on a number of certain criteria. #### 3) Triangulation

Triangulation is a validity checking technique that uses something else to compare interview results with the research object. In this research, researchers used source triangulation and data collection technique triangulation. This is intended to make comparisons between data obtained in the field through a series of data collection processes so that valid data is obtained

# 4) Adequacy of reference materials

What is meant by reference materials here is the existence of support to prove the data that has been found by researchers. For example, interview data needs to be supported by interview recordings. Data about human interactions needs to be supported by photographs. Through a series of processes for checking the validity of the data as described, the data obtained can be accounted for and then conclusions can be drawn on the found data.

#### **Result & Discussion**

#### Research sites

Tanjung Rejo Village is a village that is diverse and has a community with various religions, various ethnicities and various languages. Judging from a religious perspective, there are Islam, Buddhism and Christianity. Meanwhile, looking at ethnicity, there are the Batak, Javanese and Chinese. In everyday communication, people use Javanese, Batak, Mandarin and Indonesian. From the results of research conducted, multicultural community life in maintaining diversity in Tanjung Rejo Village is indeed well established. This is demonstrated by the existence of religious diversity and ethnic diversity. They live side by side very safely and peacefully in carrying out their daily activities. "According to several informants, the people here live in harmony and peace. There are different religions and tribes and even languages are different. However, society does not differentiate between certain blocks or groups. Mutual respect between religious communities and also between tribes. The community continues to uphold the values of tolerance and mutual cooperation. Mutual cooperation is shown when repairing

public facilities, celebrations or celebrations of happy days and also events commemorating religious holidays." So far there have been no social conflicts that could divide the people here. Even if there is a problem, it is resolved through deliberation. From research on the Head of Tanjung Rejo Village, he is of the opinion that this diversity can survive because the people of Tanjung Rejo village uphold the values of tolerance, mutual cooperation, mutual assistance, mutual respect and appreciation and also social care. And he, as the head of Tanjung Rejo village, always gives directions to the community to always maintain unity and integrity, considering that Tanjung Rejo Village is a village with a multicultural society, so all communities continue to maintain this diversity. Apart from that, in the digital era the use of technology can be seen in a number of community activities. In Tanjung Rejo village there is also potential generated from several agricultural sectors as well as the marine and fisheries sectors.

#### Village Clean Activities

Village clean-up activities are events that are still being held in Tanjung Rejo Village. This event is a celebration and prayer together with the people of Tanjung Rejo Village so that they remain safe and peaceful. "Several informants were of the opinion that this village clean-up activity still exists and is held every year, usually during the month of Suro. "In this activity, all levels of society were invited to pray together and the village head in his speech said that the community should continue and maintain unity so that Tanjung Rejo village remains safe and peaceful even though there is a variety of diversity in it." In this village clean event, the village invited all the people of Tanjung Rejo Village. In this event, the community is gathered as one, meaning there are no differences between religious groups, the entire community joins as one during the activity process.

#### Religious activity

In religious activities that are often carried out, the people carrying out the activities also involve other people, for example, during recitation, all people from other religions are also involved to help ensure that the event runs smoothly, likewise when Christians carry out religious activities such as Christmas, for example, other people also help secure these activities, and so on. All religions have their own major holidays, such as the Islamic religion the Eid al-Fitr and Eid al-Adha holidays, the Christian religion the Christmas and New Year holidays, the Hindu religion the Nyepi, Galungan and Kuningan holidays, the Buddhist religion the Vesak holiday. In research on all religious figures, which was carried out when one religion celebrated its holidays, other people also remained harmonious and respected each other. Even just visiting or wishing people who celebrate the holidays a happy holiday, either in person or via social media.

#### Social concern

In social life, an attitude of social concern is also instilled in order to maintain diversity in the current digital era. "Several informants revealed that the social attitude of the community here is such that when a resident dies, the residents automatically come to pay tribute and also help with the funeral process. This is done not only for residents of the Islamic faith, but residents of other religions also come. to condole. On the contrary, if a Christian dies, members of other religions also offer their condolences. Apart from that, charity activities for orphans and mass circumcisions are also routinely carried out. Even though in the Tanjung Rejo village community there are various religions, ethnicities, languages and cultures, so far there have been no problems that have divided the community and they still live in harmony and socialize well.

#### **Conclusion**

Based on the discussion of this research, there are several things that researchers can conclude. The conclusions in question are as follows: Tanjung Rejo Village is a village that has a multicultural society, this can be seen from the diversity of religion, language, ethnicity and culture. But even though there is diversity, all communities still live in harmony, safety and peace. So far there has been no conflict between communities. Everyone respects and appreciates each other between religious communities and between tribes. There are forms of activities in society that are carried out in order to maintain diversity in the digital era, namely village clean-up activities as well as group greetings and prayers, activities to celebrate religious holidays involving people of other religions, and social awareness.
