According to Winarno (in Nurjannah & Muslia, 2019, pp. 15-16), socialization is an activity in a person's life so that he can be accepted by society by studying various types of traditions starting from the way of life, values and social rules contained in society. Sugeng in Nurjannah & Muslia, 2019 stated that school is one of the institutions responsible for children's education and also plays a very important role in the child's socialization process. The objectives of socialization in society according to Winarto in Nurjannah & Muslia, 2019 include: 1) To understand the values and rules that apply in society, so that they can be used as insight or understanding needed for survival as a member of society. 2) To accommodate controlling various natural roles learned from good and correct self-awareness training. 3) To become familiar with the social and cultural environment to make oneself accustomed to or adapt to the values and rules that prevail in society, both at home and in new social environments. 4) In order to develop competence in interacting well, as well as developing other competences. According to Sayuti in Nurjannah & Muslia, 2019, there are two main functions in socializing in society, namely: 1) Viewed from individual interests, socialization has the object of making an individual able to understand, appreciate and adapt to the values, rules and social systems contained in public. 2) Viewed from the interests of society, socialization is a medium for maintaining, disseminating and preserving the values, rules and beliefs contained in society. So that all members of society can maintain these values, rules and beliefs. Character education as the goal of national education is stated in Law Number 20 of 2003 in chapter 1 article 1 paragraph 1 concerning the national education system which states that education is a conscious and conceptual effort to create learning situations and learning activities so that students can actively develop their abilities so that they have religious spiritual strength, self-control, personality, intellectual, moral, as well as the necessary skills himself, society, nation and state.

- 6. Hard work, hard work can show that the person or individual is an individual with character and is worth working with
- 7. Creative/creative thinking and critical thinking will indicate an intelligent individual
- 8. Democratic, meaning being fair or looking equally at the rights and obligations of oneself and others, so that one will understand what will be prioritized or what is more important to do first
- 9. Nationalism, this is very necessary because if there is no this attitude then there will never be a nation with character at any time because character itself emerges from its citizens
- 10. Caring about the natural and social environment, with care, individuals will be respected, loved and protected by the social environment.
