From 78 countries surveyed, Indonesia was ranked fifth in terms of the number of bullying cases highest among his students. According to the Chairman of the Expert Council of the Federation of Teachers' Unions Indonesia (FSGI), Retno Listyarti, her party has recorded at least 12 cases of bullying since January to May 2023. Indonesia also once shocked with case a student Junior High School in Regency Temanggung, Java Middle, which interesting attention Because burn his school on month June. Reportedly, action student the background by experience

bullying which experienced. The United Nations International Children's Emergency Fund (UNICEF) also noted that Indonesia own percentage violence child which more tall compared to with Asian countries others like Vietnam, Nepal, and Cambodia.
