Take for example Standard Competency (SK) 2 Understand system government Republic of Indonesia, Basic Competencies (KD) 2.1 Explaining the Election and Pilkada process, Materials That besides too tall for students, not yet either have urgency and usefulness for life student. Even if it's material that studied students, finally the target just in aspect cognitive, no touch life real student.

Second, lack teacher's abilities in catch keywords in SK and KD. In doing review against SK and KD this during, the teacher is still lots mistake. As a result, what is conveyed be the wrong target. By mistake catch essence of SK and KD, learning tend only leads to achievement aspect cognitive. Like examples of SK and KD above, as long as this teacher tends to only emphasizes the formulation process Pancasila (cognitive), so moment evaluation, questions that arise yes around the formulation process Pancasila.
