- 5. ## Classification a number of form behavior bullying

Behavior bullying can classified in a number of form including:

- a. Physical (hitting, kicking, slapping, pushing, biting, scratching, or abuse sexual)
- b. Non- physical (threatening, humiliating, demeaning, disturbing, or call with nickname or disability physique)
- c. Cyber (via electronic media)
- d. Non verbal contact straight (extending tongue, expression face mocking and cynical, intimidating)
- e. Non verbal contact no direct (slander, intentional) ignored or cornered, or send messages that are terror and threats)
- f. Rude words, intimidating words, name calling) telephone conditional, or calling telephone original).

a. Reject and believe that behavior *bullying* is very wrong behavior, okay in a way ethics and social norms, as well as religion.

- b. If you become a victim *of bullying*, then must brave face and fight with look for help to other people closest to you, such as for example parents, teachers and so on

For example the formation of Regulation of the Minister of Education and Culture (Permendikbud) No. 82 of 2015 concerning countermeasures action violence in schools, which aims give protection to student from action violence caused by behavior *bullying* in the environment school. Contents of Minister of Education and Culture Regulation No. 82 of 2015, specifically in Article 10 Chapter V, mandates unit education for do effort countermeasures to violence, which includes give help to the victim, report act violence to parents / guardians participant educate, identify the facts incident violence, follow up case, coordinate with party related, ensure rights and facilities participant educate, give rehabilitation and/ or facilitation to participant educate, and report incident the to the Department of Education and the authorities enforcer law local (Sabiila, 2021).

In Article 11 Chapter VI, Permendikbud No. 82 of 2015 regulates various sanctions that can be given, including unit education that can give sanctions to participant educate in the form of reprimand verbal, reprimand written, and action educative others of a nature coaching. On the side other, unit education organized by the community can give sanctions to educators, such as reprimand verbal, reprimand written, reduction rights, termination temporary / permanent from position as educator / staff education, or termination / termination connection work (Sabiila, 2021). With existence Minister of Education and Culture Regulation No. 82 of 2015, it is hoped that environment school can become a safe, comfortable and conducive place for all over participant educate. This regulation give runway clear and firm law related prevention and control act violence and behavior bullying in the environment schools and units education, as well as confirm commitment government in protect children from action violence in form whatever. Further efforts that can be made done government in to fight case bullying that is with realizing and implementing effective anti - bullying programs for create environment safe and inclusive learning for students . One of the example of the program is anti bullying Teacher Empowerment Program (TEP) which is a program formed by the semai jiwa amini foundation.
